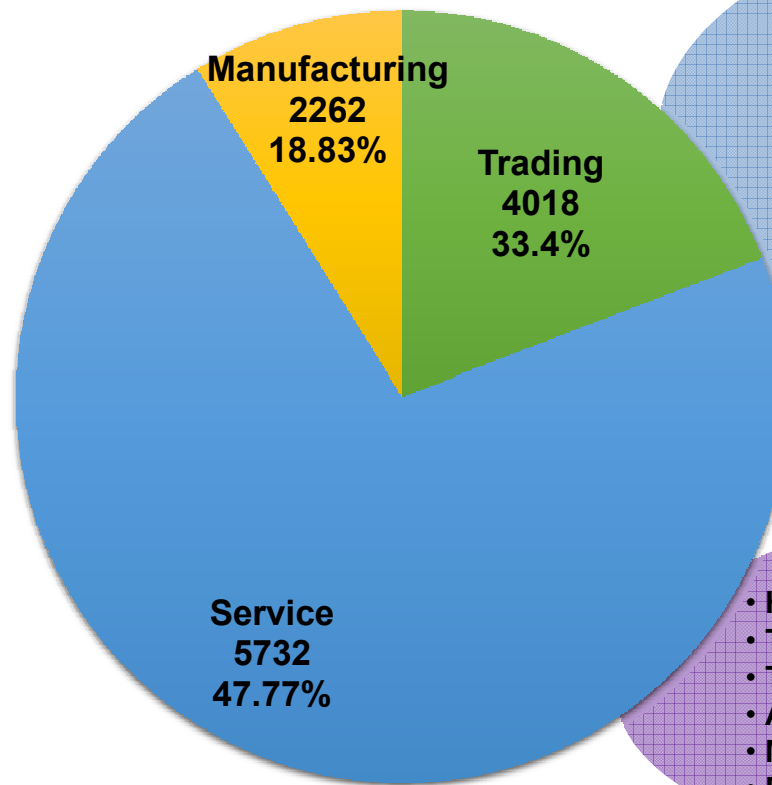

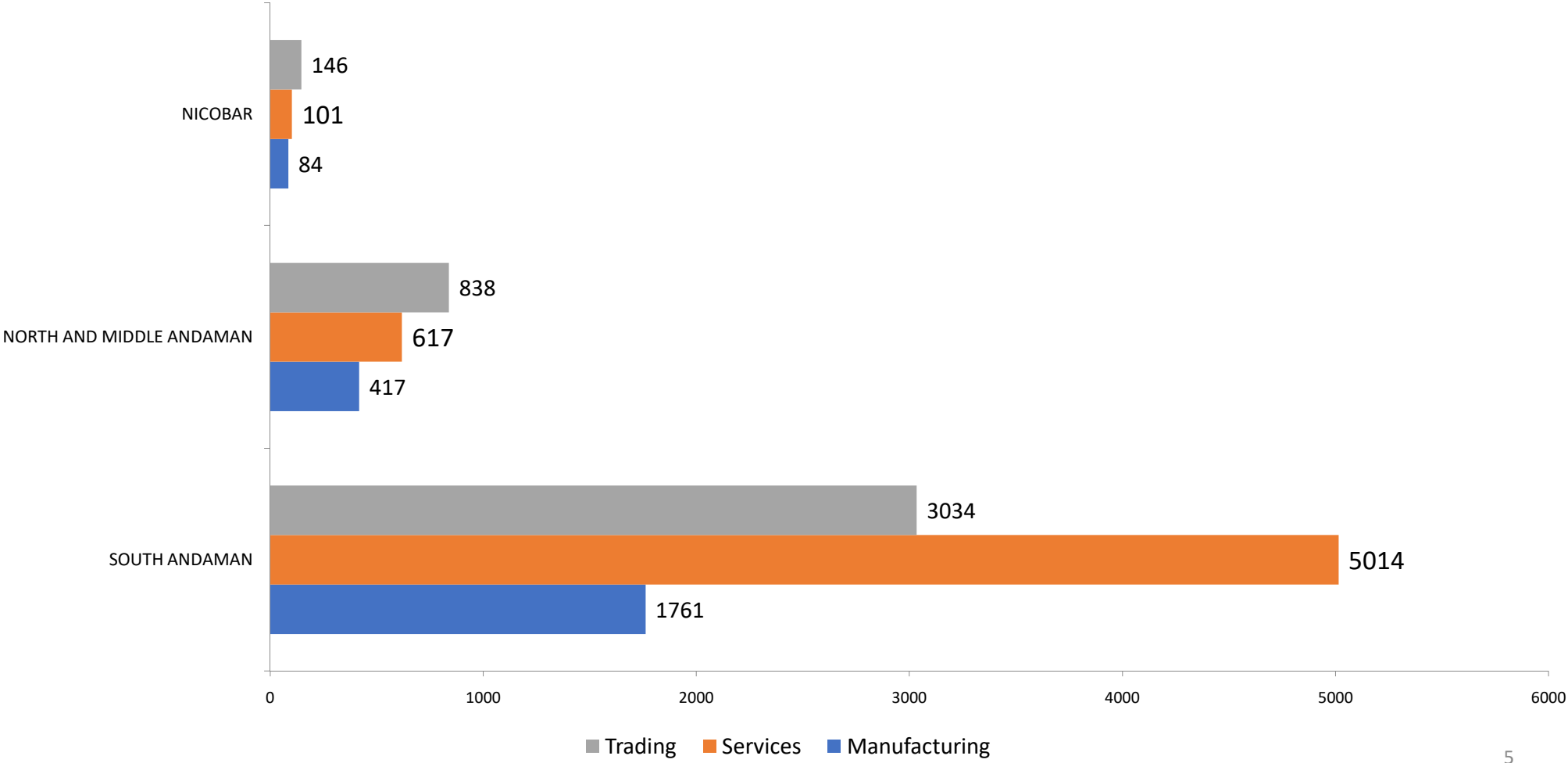

District Wise Distribution of Registered MSME in Udyam Portal



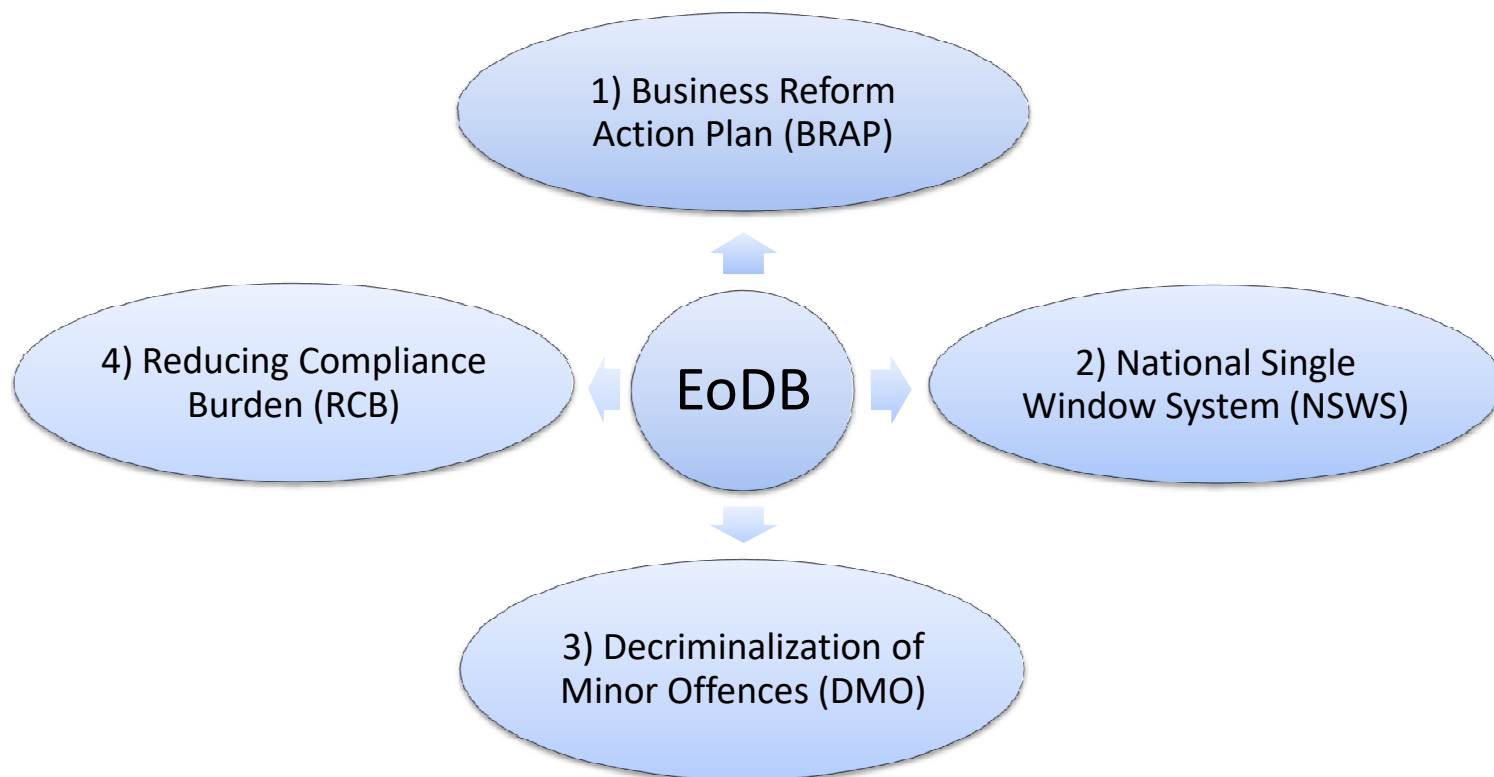

02 -National Single Window System (NSWS)



- ❑ **68 KYA (Know Your Approvals)** pertaining to A&N Islands were soft launched in NSWS portal: www.nsws.gov.in from 13th October, 2022
- ❑ **30 services** pertaining to 07 departments have been **integrated** in the NSWS portal.



03 - Decriminalisation of Minor Offences (DMO)

- ❑ ANI being an UT without Legislature and have several Regulations promulgated under Article 240 of the Constitution.
- ❑ Pursuant to directives of DPIIT, the UT administration has reviewed all the provisions of minor offences towards **decriminalization** and uploaded in the RC portal.
- ❑ [25 Acts, 9 Rules](#) & [49 Regulations](#) were reviewed towards decriminalization of minor offences wherever possible.
- ❑ 30 provisions of Labour department and 06 provisions of Revenue department have been recommended for decriminalization.



04 - Regulatory Compliance Burden (RCB)

Initiated on the directions received from the Cabinet Secretary in 2020.

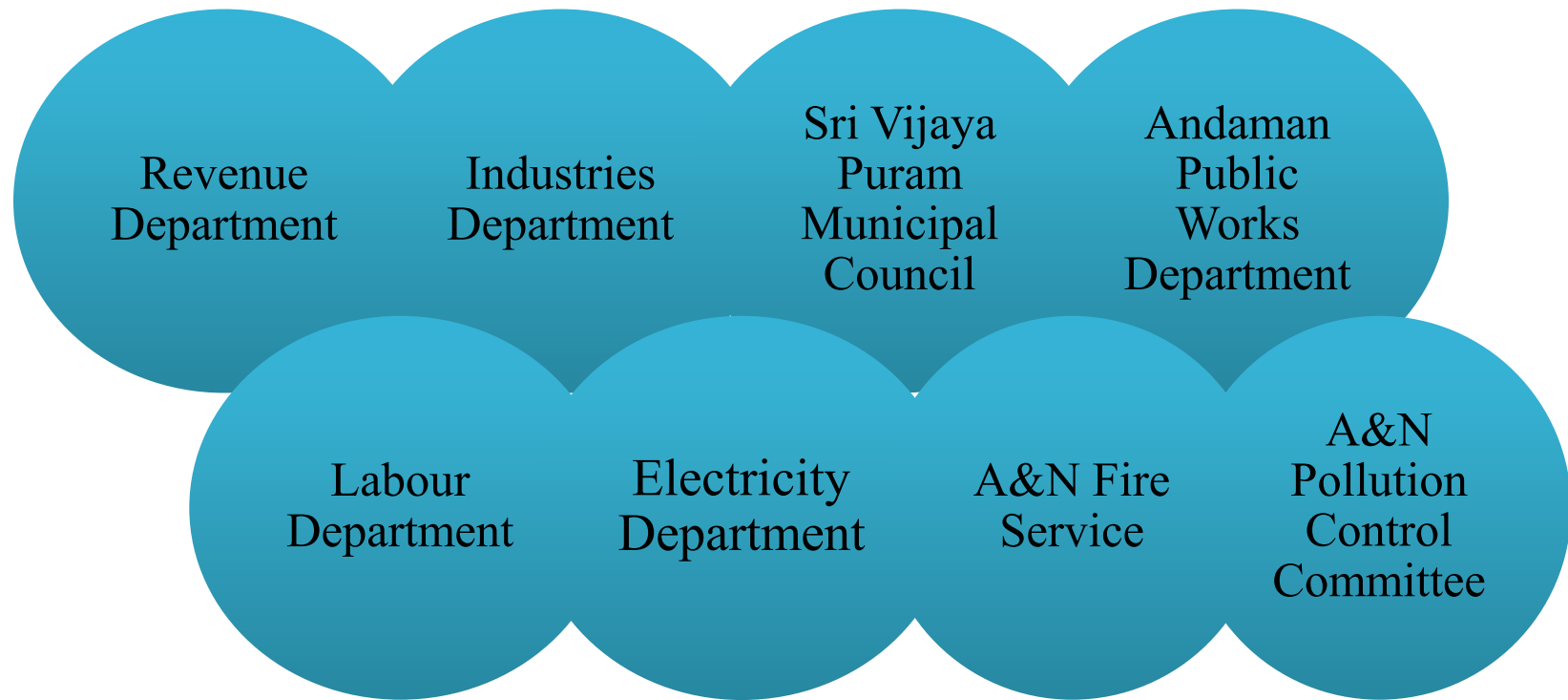

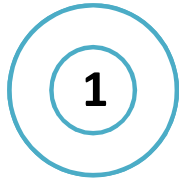

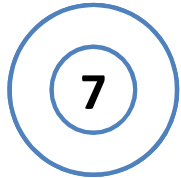

As third party empanelled Licensed Architect & Engineers has submit the drawings and required documents on behalf of applicant for approval of building plan and he is also responsible of submitting the inspection report stage wise and notify the violations if any.

For issue of an occupancy & completion certificate, a third party structural stability certificate is issued by an empanelled licensed engineer for the onward issuance of occupancy /completion certificate.

- Upon receiving concurrence, the department shall initiate further process.

Priority Area: Revise the working hours limit for factories**Existing Law, Rules and Regulation**

The Section 51, 56 59 and 65 of the Factories Act, 1948 are relating to the working hours in the factories

Input of the Department

- The Ministry of Labour and Employment has recently proposed 09 Labour reforms in the existing Labour Laws, wherein one of the Labour reforms is to enhance quarterly overtime hours limit (from 75 up to 125 hours) Accordingly, in pursuance to the directions of the MoL&E and the meeting held by the MHA on 05.03.2025, a draft notification to amend Section 65 of the Factories Act to enhance quarterly overtime hours limit (from 75 up to 125 hours) has been submitted to the MHA for concurrence on 06.03.2025.
- Upon receiving concurrence of MHA, the department shall initiate further process.
- Pertaining to amendment of working hours and spread over, it is submitted that the existing Law is sufficient to support implementation of the priority area concerned as currently only 30 Nos factories are licensed from Govt. Sector and 09 factories from private sector.
- As such the existing Law is sufficient to support implementation of the priority area concerned.

- The department has kept only the minimum statutory documents required for obtaining licenses as required under the Factories Act, 1948 and A & N Islands Shops and Establishment Regulation, 2004.
- The documents required for factory licence: (1) Form-1 (2) Plant lay-out (3) Details of manufacturing process including flowchart. The documents required for shops/establishments registration: (1) property details (2) photograph of the establishment (3) Identity card of employer.
- The Labour department is not issuing Trade Licence under any Regulation/Act.
- The entire process for issuance of Registration Certificate and its renewal under the Shops and Establishment Regulation has been made online since 2018.
- The employer is not required to furnish or submit any kind of documents for renewal under Factories Act or A&N islands Shops and Establishment Regulations.

- The Object of the A & N Islands Shops and Establishment Regulation, 2004 is to regulate the working conditions of the workers such as timely payment of wages, working hours, weekly off etc.
- It is submitted that major numbers of the shops and establishments are having less than 10 workers in the UT of ANI. The data are as follows:-

Only 78 shops/establishments have employed more than 20 employees

Raising the threshold for compliance under the Shops and Establishment Regulation to 20 workers will deprive the workers from ensuring the payment of wages within due date, working hours, weekly off etc. As such the existing Law is sufficient to support implementation of the priority area concerned.

Priority Area: Re-classification of non-polluting industries as White Category for granting Consent to Establish and Consent to Operate under the Air Act, 1981, and the Water Act, 1974
