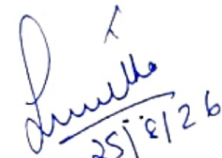

NOTIFICATION

F. No. M-17036/4/2022-DD-III-Indus-INDS_AN/ — In exercise of the powers conferred by the Andaman and Nicobar Administration, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, is hereby proposes to make the following Amendments to the *Andaman and Nicobar Islands Industrial Estate (Allotment & Management) Policy, 2025*, published in the Andaman and Nicobar Gazette vide Notification No. 12/2025 / F. No. M-17036/4/2022 dated 28.02.2025, namely:

Objections and suggestions are invited from the stakeholders/persons to be affected thereby. The objections and suggestions (if any) should reach the office of the Director of Industries, A&N Administration within 30 days from the date of its publication in the official website for examination and consideration.

1. Short Title and Commencement

- i. This Policy may be called the **Andaman & Nicobar Islands Industrial Estate (Allotment & Management) Amendment Policy, 2026**.
- ii. It shall extend to the whole of the **Andaman and Nicobar Islands**.
- iii. These amendments shall come into force from the date of publication of this Notification in the **Official Gazette**.

AMENDMENTS

I. Amendments in Chapter-2 (General Provisions / Planning & Allotment)

1. Clause 2.2 (Name of Committee)

The term "*Compilation Committee*" shall be substituted with "*Management Committee*".

2. Clause 2.2.1 (h) (Membership)

Amended as "Any other officer from any Department/Government Institution/representatives from Industry bodies such as ANCCI /Industry experts as may be required as a Co-opted member.

3. Clauses 2.2.3.1(a) & 2.2.3.2(a) (Master Plan Reference)

The reference to specific clauses of the Master Plan for Port Blair Planning Area shall be replaced with:

“Master Plan of the concerned Area and other applicable guidelines/plans for other areas of A&N Islands, as amended from time to time by the Competent Authority.”

4. Clauses 2.2.3.1(e) & 2.2.3.2(b) (Plot Size)

Plot size norms shall be governed as per the applicable Master Plan and relevant guidelines issued from time to time.

5. Chapter-2 & Chapter-16 (Execution Agency)

The term *“through APWD”* shall be substituted with:

“through APWD/PPP/any other agency, with approval of the Competent Authority.”
